Subject: Revision of pension of pre 2007 pensioners/family pensioners retirees from
BSNL Corporate office.

Reference is invited to this office O.M. No. 40-17/2008-Pen(T)-Vol-III dated 15th March,2011 followed by this office letter of even no. dated 05.04.2011 on the subject cited above. It was requested that payment of pension at revised rates should start from the month of July, 2011 and payment of arrears should be completed by 30th September 2011. Efforts should be made by all the authorities concerned to ensure that the revised PPO's are issued with in time bound manner.

However, through various representations, the BSNL and DOT pensioner's Welfare Associations have pointed out the slow pace of the revision of PPOs. Secretary(T) has issued a letter to CMD BSNL to look into the matter personally and take appropriate steps including deployment of extra manpower, if required, in order to ensure the implementation of the decision in a time bound manner.

Since the position is to be put up to Secretary(T), it is requested that revised PPOs may be issued with in prescribed time limit and status report on revision of PPO's of pre 2007 pensioners/family pensioners may be sent to this office immediately in the format as below.
