Sub: BSNLMRS – guidelines for regulation of expenditure on indoor treatment – cases where no CGHS rates are prescribed for any treatment/procedure.

Cases are referred to Corporate Office for settlement of medical claims where CGHS rates are not available. Where CGHS rates are not available, the cases are settled as per AIIMS rates. On seeking rates from AIIMS for various implants/devices and procedures, Administrative Office (H) of AIIMS has informed that the rate list of AIIMS is available on their website - www.aiims.edu / www.aiims.ac.in (link Hospital Zone-patient care service), wherever the rates of a particular disease are not available, the concerned Department/specialist doctor may be contacted (copy enclosed).

All the field units are requested to refer the rate list of AIIMS at their website and in case of non-availability of rates in the rate list they may directly refer their cases to concerned department of the AIIMS.
